**PRESCHOOL TUITION AGREEMENT**

This Agreement reserves a place at Miss Marie's learning Center for the 2011-2012 school year at a tuition rate

We agree to pay the tuition specified herein for the above student according to the chosen payment schedule (circle one of the following):

1. A payment of the full tuition amount on or before the first day of each month
2. Three tuition payments on September 1, December 1, March 1

We understand that we are responsible for the tuition charged per quarter school year. If we transfer our child to another school or remove him/her for any reason, we understand that we will be charged tuition for the entire quarter. (Fall Quarter: Sept. – Nov.; Winter Quarter: Dec. – Feb.; Spring Quarter: March – May)

**Late Departure:** I agree to pay two (2) dollars for each minute or portion thereof for services provided by the school outside of the regularly selected schedule (i.e. full time schedule or part time schedule). I acknowledge the right of the school to notify an appropriate government agency if my child remains at the school an hour or more past the close of business.

**Discounts:** If two children with the same sponsor are enrolled full day every day, a 10% discount is applied to the older child's tuition.

**Tuition Increases:** Miss Marie's Learning Center agrees to hold the tuition rate at the above level for the time period that the child (children) is (are) in continuous enrollment (no gap of 30 days or more).

**Sick / Vacation Policy:** Tuition refunds cannot be given for individual days or weeks children are absent

**Late Payments:** Tuition is due on the first of the month. I agree to pay a \$5 per day late fee for tuition received after the 5th of the month. Should tuition remain unpaid on the 10th of the month Miss Marie's learning Center will withhold services until such time as all tuition and late fees are paid

**Returned Checks:** If your check is returned or rejected for any reasons, you expressly authorize your bank account to be electronically debited for the amount of the check plus a processing fee of \$25.

**Dismissal:** Miss Marie's Learning Center reserves the right to suspend or dismiss students for unsatisfactory conduct or for educational or medical concerns, which are beyond the expertise of the school or program incompatibility.

**Termination:** To terminate this agreement, the Parent (s) must submit a written thirty (30) day notice to terminate or change the schedule. I understand that this contract with Miss Marie's Learning Center will remain in full force throughout our time at Miss Marie's Learning Center and supersedes all other agreements.

**Interest:** If a balance remains owed 30 days after the termination date, I understand an interest fee of 10% will be added each month on the unpaid balance.

**Attorney Fees:** Should the services of an attorney be necessary to enforce this agreement, the prevailing party shall be entitled to a responsible sum for Attorney fees.

The registration fee is non refundable.
